02 1. The following is reported for your information. In late December 1963 (UNCLAPU/9 reported that (UNCLAPU/8 received a telephone call from Evanes on 21 December from his nephew IDEN who is also an old friend of ANLASH/1. IDEN told (UNCLAPU/8 that ANLASH/1 had had an interview with Genl ROA concerning the 02 dismissal of (UNCLAPU/8 and (UNCLAPU/9. IDEN also advised that Major CUNEO, who visited Paris in September and October 1963 and who is also a friend of 02 (UNCLAPU/8 and (UNCLAPU/9 and ANLASH/1 had interceded with ROA. IDEN stated 02 (UNCLAPU/8 and (UNCLAPU/9 now do not have to worry about their jobs.

02 2. The following is a gist of a letter dated 22 January from ANLASH/1 to (UNCLAPU/9 and received by the latter approximately 25 January. ANLASH/1 says that (UNCLAPU/9 now is secure in his present job. The letter implies that ANLASH/1 and Major CUNEO are responsible for this. 02 (UNCLAPU/9 should work hard and cooperate with the new Ambassador who will appreciate the good job 02 (UNCLAPU/9 is doing in Paris. ANLASH/1 received a letter on 29 January from AMRHIP/1 who will be going to Paris soon. ANLASH/1 asks that (UNCLAPU/9 and AMRHIP/1 telephone him when the latter arrives in Paris. He also asks that AMRHIP/1 "sec" on the pullover he provided me." ANLASH/1 stated he hopes to 02 visit (UNCLAPU/9 this year and is looking forward to (UNCLAPU/9's visit to Cuba this summer. ANLASH/1 is now working in IDEN B. 02

3. Does Headquarters wish Paris Station to continue similar reporting indications of ANLASH/1 position? Was any type open code system worked out with ANLASH/1 that Paris Station should watch for in communications from ANLASH/1?
