1. IN ACCORDANCE REFS COS AND LANGOSCH MET [REDACTED] MORNING 23 SEPTEMBER IN COS OFFICE TO BRIEF HIM ON [REDACTED] RECRUITMENT, IMPORTANCE AND SECURITY CONSIDERATIONS. [REDACTED] WAS MUCH IMPRESSED AND AGREED EMPHATICALLY ONLY HE AND [REDACTED] WOULD KNOW RECRUITMENT AND THEY WOULD MAKE NO RECORD OF IT. DURING [REDACTED] LANGOSCH POINTED OUT [REDACTED] IS MOST IMPORTANT LOCAL TARGET BECAUSE HE HAS KNOWLEDGE OF AND ACCESS TO COMMIE PARTIES SALV AND OTHER COUNTRIES, IS POPULAR [REDACTED] COMMITTEE, TRAVELS FREQUENTLY TO CONGRESS, SUCH AS AT MOSCOW, PRAGUE, NEXI, CARA AND BRITISH SEASIDE. [REDACTED] HAD LOW CONTACTS, [REDACTED] AND ALTHOUGH [REDACTED] YEARS OLD HAS BEEN [REDACTED] SINCE [REDACTED] POTENTIAL IN PARTY; BUT THAT ANY INDISCRETION COULD RESULT IN LOSS OF [REDACTED] AND ALL HE COULD PRODUCE FOR YEARS TO COME.

ARRANGED CONTACT WITH [JUNAVE 2] ⁰². [DUNHILL] ⁰¹ ACCEPTED WITHOUT QUESTION, MADE NO DEMANDS, ORDERED ALL HIS FACILITIES AND UTMOST COOPERATION, TO KUBARK. CCS AND LANGOSCH BELIEVE THERE HAS BEEN NO SECURITY PROBLEM TO DATE.

3. DO NOT PLAN HIT ANY OTHER TARGETS SALV AT THIS TIME, EXCEPT [JUNAVE 1] ⁰², AS [JUNAVE 2] ⁰² OP TOO IMPORTANT TO RISK DRAWING ATTENTION TO KUBARK PRESENCE OR RECRUITMENT EFFORTS. PLAN TO CONTINUE [JUNAVE 1] ⁰² INTERROGATION AND RECRUITMENT EFFORT. HIS SILENCE AND COLLABORATION IMPORTANT IN THEMSELVES BUT ALSO FOR FOREGOING REASON. [DUNHILL] ⁰¹ AGREES HANDLE EXACTLY AS KUBARK WISHES.

4. HAVE NOT SPECIFIED AMOUNT OF PENETRATION TO [JUNAVE 2] ⁰² EXCEPT THAT IT WILL INCLUDE PAYING COST OF SUPPLEMENT STUDIES OF BROTHER IN WHATEVER COUNTRY KUBARK CONSIDERS BEST FROM VIEWPOINT OF ADEQUATE SCHOOL OR INSTITUTE AS WELL AS FROM SECURITY STANDPOINT. AFTER GRADUATION NEED BROTHER HAS SPECIALIZED IN [REDACTED] ESPECIALLY [REDACTED] ⁰² NOW COMPLETING WORK AT ILEN AND EXPECTED RETURN ONLY OCTOBER. HAVE TOLD [JUNAVE 2] ⁰² BROTHER MUST HAVE SCHOOL AND OTHER RECORDS TO ESTABLISH COMPETENCE IN APPLYING FOR ADMISSION. MUST BE ASAP SUGGEST SCHOOLS, HOSPITALS OR RESEARCH INSTITUTES WHERE BROTHER SHOULD APPLY AND WHERE PREFERABLY KUBARK SECRETLY CAN FACILITATE RAPID ACCEPTANCE, TOGETHER WITH SUGGESTED MEANS PAYING COSTS. BROTHER SPEAKS ONLY SPANISH BUT HAS READING KNOWLEDGE OF ENGLISH AND FRENCH. HAVE TOLD [JUNAVE 2] ⁰² BROTHER MUST BELIEVE ONLY TO BE FINANCED BY [JUNAVE 2] ⁰² AND ACCEPTANCE AT INSTITUTE ON GRANTING OF SCHOLARSHIP ARE STRICTLY ON OWN MERITS.
