

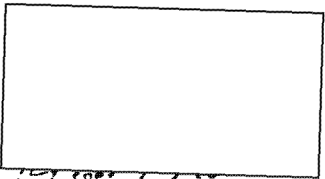

1. STONESSET WHO EN ROUTE HAS BEEN BRIEFED ON DEVELOPMENTS THROUGH MORNING 26 SEPTEMBER.
2. ⁰²[J]AVAVE 1 TRANSFERRED TO PRIVATE HOUSE NEAR SA. SALV 25 SEPTEMBER. LANGOSCH INTERROGATED NIGHT OF 25 SEPTEMBER. RESULTS:
 - A. GAVE PERSONAL ^HHISTORY. 29
 - B. TALKED OF EARLY DAYS IN [] AND IDENTIFIED MEMBERS OF CELL TO WHICH HE BELONGED. CLAIMED HE LEFT PARTY 1948. DISCLAIMS KNOWLEDGE OF PARTY ACTIVITIES, CENTRAL COMMITTEE, KEY FIGURES. SAYS SYMPATHIZED WITH PARTY AIMS EVEN THOUGH PARTY USES QUESTIONABLE MEANS.
 - C. LISTED FRIENDS AND ACQUAINTANCES MEXICO AND CUBA, CLAIMING ALL KNOWN BECAUSE INTERESTED IN LITERARY ACTIVITIES OR MET IN CONNECTION WITH HIS TRAVELS.
 - D. CONTINUED DENY ANY INTEL TRAINING.
 - E. CONTINUED PLEAD FOR RELEASE IN RETURN FOR PROMISE LEAVE COUNTRY AND "NEVER ENGAGE IN POLITICAL ACTIVITIES."
