1. MR. JULIAN G. SOURWINE, CHIEF COUNSEL OF THE SENATE INTERNAL SUBCOMMITTEE, RECENTLY ADVISED WOFAC OFFICE OF LEGISLATIVE COUNSEL THAT [REDACTED] (201-729568), CURRENTLY IN CUBA, WISHES TO DEFECT BUT WILL DO SO ONLY IF HE CAN BRING OUT HIS FAMILY.

2. SOURWINE DID NOT DIVULGE IDENTITY HIS SOURCE NOR INDICATE HOW INFO ACQUIRED. ACCORDING TO SOURWINE, [REDACTED] RECENTLY TRAVELED ABROAD BUT ITINERARY NOT REVEALED.

3. HQS TRAVEL RECORDS SHOW FOLLOWING TRAVEL [REDACTED] (CUBAN DIPLOMATIC PASSPORTS [REDACTED] AND [REDACTED]):

- A. JULY 62: CUBA TO CZECHOSLOVAKIA TO USSR; CZECHOSLOVAKIA TO CUBA.
- B. 2 SEPT 65: CUBA TO USSR.
