ACCORDING [redacted] MERCEDES "MECHE" ESCAMILLA LIVED AT NUEVO LEON 209 ADDRESS WITH BROTHER JOSE, <sup>MOTHER AND SISTER</sup> "MECHE" WAS SOMETIME MISTRESS OF MAURICIO DE LA SELVA (THEY FOUGHT FREQUENTLY). <sup>THE AGENT</sup> DOES NOT RECALL THAT BROTHERS TRUE NAME WAS JOSE TOMAS ESCAMILLA, AND BELIEVES INSTEAD THAT EITHER <sup>HE</sup> JOSE OR THE TOMAS WAS TO BE ADDED IN CORRESPONDENCE AS S/W INDICATOR. (COMMENT: <sup>THE AGENT</sup> PROBABLY CONFUSED, SINCE S/W WAS TO BE INDICATED BY SPELLING 'SURNAME ESCAMILLO, ACCORDING POT FILE). <sup>THE AGENT</sup> SAID JOSE WAS ONLY PARTIALLY WITTING.

2.) TELEPHONE NUMBER USED WITH NUEVO LEON ACCOMODATION ADDRESS--46 19 95-- BELONGED TO APT BUILDING IN WHICH MAURICIO DE LA SELVA LIVED. <sup>EP</sup> IT WAS LOCATED ON CALLE ASTRONOMOS AT CORNER OF CALLE VIADUCTO ALEMAN. [redacted]

5. <sup>THE AGENT</sup> DOES NOT KNOW CURRENT ADDRESS OF MAURICIO. SAID MAURICIO

MOVES FREQUENTLY DUE FINANCIAL PROBLEMS. WHEN HE STAYED WITH HIM

HE WAS LIVING IN APT 05 CALLE EZEQUIEL MONTES. WAS LIVING AT  
ALLE ASTRONOMOS ADDRESS AT TIME <sup>THE AGENT</sup> LEFT MEXI <sup>1962</sup>

6. <sup>THE AGENT</sup> RECALLS WRITING ONLY ONE S/W MESSAGE WHILE IN MEXI AND SAYS CANNOT REMEMBER WHETHER HE DELIVERED IT PERSONALLY TO "MARCOS" OR WHETHER HE GAVE IT TO "PECHS" TO PASS. SAYS HE HAD<sup>3</sup> NEVER ATTEMPTED TO COMMUNICATE WITH DGI SINCE LEAVING MEXI.
