30 OCT.
2. FYI, LOCAL NEWSPAPER PUBLISHED LETTER FROM SUBJ 30 OCT IN WHICH  
SUBJ CLAIMED THAT HE ESCAPED HE WAS HELD IN CONFINEMENT BY POLICE  
AND INTERROGATED BY ~~AN AMERICAN~~ AND PERSON WHO CLAIMED TO  
BE ~~A CUBAN~~ WHO MADE COMPLETELY ABSURD CHARGES THAT  
HE HAD PARTICIPATED IN ~~CUBAN~~-DIRECTED PLOT AGAINST SALV. SAID HE  
FOUND OUT LATER THAT THE SELF-STYLED ~~CUBAN~~ WAS FORMERLY A LOCAL  
POLICE INSTRUCTOR.
3. ALTHOUGH LETTER MAILED IN SALV, SUBJ MAY FLEE TO NEIGHBORING
