FIELD REPORT NO.

1. ON 3 NOVEMBER 1965 AN ADHERENT OF FULGENCIO BATISTA ZALDIVAR, FORMER PRESIDENT OF CUBA, SAID THAT BATISTA IS INTERESTED IN GAINING CONTROL OF A CUBAN EMIGRE ORGANIZATION THROUGH WHICH HE COULD INFLUENCE A LARGE NUMBER OF CUBAN EMIGRES IN THE UNITED STATES.

HOWEVER, HE DOES NOT WANT THE ORGANIZATION TO BECOME KNOWN AS A "BATISTIANO" ORGANIZATION.

2. BATISTA'S REPRESENTATIVES IN THE UNITED STATES HAVE BEEN INSTRUCTED TO ATTEMPT TO GAIN CONTROL OF THE REPRESENTACION CUBANA EN EL EXILIO (RECE. CUBAN REPRESENTATION IN EXILE). SANTIAGO

 EFFORT TO RALLY EMIGRE SUPPORT FOR RECE, AND SINCE MID-SUMMER 1965
 HAS BEEN ACTIVELY WORKING TO GAIN THE SUPPORT OF THE VARIOUS EMIGRE
 PROFESSIONAL ORGANIZATIONS AND TO REACH AN AGREEMENT WITH ALL
 RIGHTIST GROUPS AND WITH FOLLOWERS OF BATISTA. REY AND GARCIA
 HAVE BEEN FREYRE'S CONTACTS WITH THE PRO-BATISTA GROUP. FREYRE
 HAS GIVEN MONEY TO GARCIA IN ORDER THAT THE NEWSPAPER PATRIA
 WOULD CAMPAIGN IN ITS EDITORIALS FOR THE NEED TO SUPPORT
 THE EMIGRE WHICH WOULD REPRESENT ALL EMIGRES.)
