SUBJECT 201-234248

1. AS OF 13 JANUARY 1965 MANUEL RAY RIVERO, LEADER OF THE JUNTA REVOLUCIONARIA CUBANA (JURE, CUBAN REVOLUTIONARY JUNTA), WAS PLANNING TO INFILTRATE INTO CUBA ON 1 OR 5 FEBRUARY. THE M/V VENUS, A 110-FOOT PANAMANIAN-REGISTERED VESSEL, WAS UNDER REPAIR AND THE SHIP'S CREW WAS GIVEN PERMISSION TO RETURN TO MIAMI ON LIBERTY. (FIELD COMMENT: THE SAME SOURCE RECENTLY REPORTED THAT RAY INTENDED TO INFILTRATE INTO CUBA SOMETIME BETWEEN 15 AND 20 JANUARY.)

2. ALL THE MEN OF JURE'S CAMP IN THE DOMINICAN REPUBLIC WERE A LITTLE DISGUSTED BECAUSE THEY DO NOT THINK THAT RAY WILL

REALLY GO TO CUBA. THEY HAVE GIVEN HIM 5 FEBRUARY AS A DEADLINE.

(SOURCE COMMENT: IF RAY DOES NOT LEAVE FOR CUBA BY THIS DATE, HE WILL PROBABLY LOSE ALL HIS MEN. THEY ARE ALL ANXIOUS TO SEE ACTION BUT RAY HAS BEEN GIVING THEM NOTHING BUT PROMISES AND PLANS.)
