REF: YOUR MSG THROUGH CAS CHARMELS OF 13 MOVEMBER 1964.

- 1. I SAV PRESIDENT ORLICH AND MINISTER QUIROS SASSO ON 13 NOVEMBER AND CONVEYED REFERENCE POSITION. THE PRESIDENT AND VISIELY SHAKEN TO LEARN THAT US GOVERNMENT WAS NOT WINVOLVED IN THIS ARMS SHIPMENT. AFTER SOME DISCUSSION WITH MINISTER QUIROS, PRESIDENT ORLICH REQUESTED THAT WE NOT ISSUE LICENSE FOR AMERICAL SHIPMENT.
- FRESIDENT ORLICH MADE CLEAR HE WOULD BE HAPPY AT ANY TIME TO UNDERTAKE ACTION SUCH AS THIS IF US. GOVERNMENT WANTED HIMSTOO. WHILE HE DOES WISH SEE CUEA FREE HE INCLINED TO AGREE WITH U.S. POSITION RE HIT AND RUN RAIDS UNDERTAKEN PRINCIPALLY FOR PUBLICITY SAKE.
- 5. PRESIDENT ORLICH'S DECISION EASED ON (1) REALIZATION THAT WOULD NOT BE DOING AN A FAVOR AND, (2) FURTHER REALIZATION THAT CRG WOULD EL MANG PRESSED TO EXPLAIN SUCH A 570,000 RURCHASE OF ARMS IF IT BECAME A CAMPAIGN ISSUE IN 1965.
