1. IN PAST HAVE REFERRED IN TRAFFIC WITH YOU TO OSTENSIBLE PRIVATE PEPRIIME GROUP, WHICH HAS BECOME PRIMARY CENTRAL CONTACT JMARC COMPLEX. REPRESENTATIVE THIS GROUP IS KUBARK STAFFER WALLACE R. PARLETT (IDEN), WHO UNDER ALIAS FRANK BENDER TRANSACTS APPROPRIATE BUSINESS. FOR SIMPLICITY SHALL REFER TO THIS ARRANGEMENT IN FUTURE TRAFFIC AS "GRUPO BENDER"

BENDER MET MARTINEZ FRAGA IN MIAMI, IDENTIFYING HIMSELF AS INDIVIDUAL IN CONTACT AMMAIL, ⁰²QDCOVE, AMBIDDY-1, AND OTHERS FOR THE PURPOSE OF FURTHERING JMARC EFFORT, INDICATED TO MARTINEZ FRAGA DESIRE ⁰²DRAW LATTERS ~~IN~~ ON MATTERS CONSIDERABLE KNOWLEDGE AND WOULD APPRECIATE HIS COUNSEL. FURTHER INDICATED WOULD APPRECIATE MARTINEZ FRAGA'S INFLUENCE IN BRIDGING SOME OF MINOR DIFFERENCES OF OPINION WHICH ~~WILL~~ ⁰²ARISE OR MIGHT OCCUR IN FUTURE BETWEEN VARIOUS FACTIONS, WHICH ALL CONCERNED ARE EAGER TO CEMENT INTO COHESIVE DYNAMIC ENTITY. MARTINEZ FRAGA WAS EXTREMELY COOPERATIVE AND MADE SAME NIGHT HIS INFLUENCE FELT ON ⁰²QDCOVE, WHO IN PAST HAD BEEN RELUCTANT TO COOPERATE AMMAIL. DURING MEETING 19 APRIL BETWEEN BENDER, AMBIDDY-1, AND ⁰²QDCOVE POINT WAS MADE NEED CLOSEST COOPERATION ALL CONCERNED. IT APPEARS AT MOMENT THAT PAST DIFFERENCES MAY HAVE BEEN PUT
