TONY NUÑEZ "TONY" OF UR AND ANGEL BOSS "GUILIN" OF MERC LEFT
HQS P.M. 29 SEPT FOR WAVE.

2. JUSTO WAS SPORADICAN AND DEFINITE LEADER OF GROUP
 INCLUDING BOSS AND HIS MERC. JUSTO MADE GOOD IMPRESSION AND
 SEEMED SINCERE, CAPABLE AND TO KNOW WHAT HE WAS AFTER AND WHERE

3. THEY ASKED IF THEY HAD TO GO THROUGH AMBUD-1 AND
WERE TOLD THEY COULD DEAL DIRECTLY WITH PETERS. PHONE NUMBER OF
JUSTO FOR CONTACT IS FE-3-1306. THAT OF BOSS IS HI-3-7097.
HOWEVER, LEAVE DISCRETION WAVE USE CUTOUTS.

4. NO COMMITMENTS WERE MADE. THEY WERE ASKED TO COOPERATE
WITH AMBUD-1 TO GET ALONG WITH LV AND USE HIM BUT NOT FIGHT HIM
AND AFTER MAKING THIS ATTEMPT IF THEY STILL COULD NOT GET ALONG
WITH AMBUD-1 WE WOULD NOT DENY SUPPORT.
