A. RE PARA 1 - ALL ITEMS APPEAR REASONABLE WITH EXCEPTION GROCERIES AND CO². NO DOUBT GROCERY FIGURE REPRESENTS TOTAL EXPENDED FOR VOYAGE SUSTENANCE AND STABLE RATION TO BE CARRIED IN WITH TEAM. VIEW OP OUTCOME WAVE CAN REQUEST RETURN STABLE RATION AND CO² OR DEDUCT THEIR COST. VIEW LACK ITEMIZED FOOD BILL RECOMMEND GROCERY TOTAL BE HALVED.
