SOURCE AND APPRAISAL

FIELD REPORT NO. UFG-7222

A MIAMI BUSINESSMAN WHO WAS A RESIDENT OF HAVANA FOR SEVERAL YEARS. THE SOURCE HAS CONTACTS WHO RECOGNIZE HIM AS A CHANNEL TO US INTELLIGENCE. THIS INFORMATION WAS OBTAINED FROM AN INDIVIDUAL WHO TALKED TO MIGUEL ALAYON.

1. JUST PRIOR TO 28 MAY 1965, MIGUEL ALAYON, A CUBAN PILOT WHO IS PLANNING TO BOMB A TARGET IN CUBA, PURCHASED 100 POUNDS OF DYNAMITE, AT ONE DOLLAR A POUND, FROM ROBERTO LOPEZ MARRERO. ALAYON ALREADY HAS THE CASING FOR A 100 POUND BOMB, WHICH IS EQUIPPED WITH A NOSE CONTACT FUSE AND A REAR PERCUSSION FUSE; ALAYON, WHO WENT TO KEY WEST, FLORIDA, ON 27 MAY, APPARENTLY TESTED SOME OF THE DYNAMITE IN THE FLORIDA EVERGLADES AND DETERMINED THAT IT WAS GOOD.
