<p>30 NOVEMBER GROUP. IT SOON BECAME APPARENT, HOWEVER, THAT RODRIGUEZ WAS TRYING TO FIND AN ORGANIZATION WHICH COULD BE LED BY JOSE (MIRO) CARDONA, FORMER PRESIDENT OF THE CUBAN REVOLUTIONARY COUNCIL (CRC). ALTHOUGH THE 30 NOVEMBER GROUP DID NOT MAKE MIRO'S LEADERSHIP A STIPULATION OF THEIR AGREEMENT, THE MRP, SUSPICIOUS OF THE MOTIVES OF THE 30 NOVEMBER GROUP, BACKED OUT OF THE NEGOTIATIONS. (SOURCE COMMENT; ON 29 APRIL AT 11 A.M. RADIO CARIBE IN SANTO DOMINGO CARRIED A THREE-MINUTE MRP TAPE AS PART OF A HALF-HOUR BROADCAST REGULARLY PRODUCED BY MAX LESNICK AND BEAMED TO THE CUBAN POPULATION. <u>MRP PUBLIC RELATIONS COORDINATOR</u> JOAQUIN <sup>F</sup> (GODOY) <sup>C.I. Cuba</sup> SOLTS DELIVERED THE MRP MESSAGE WHICH ANNOUNCED THE UNIFICATION OF THE MRP WITH ALPHA-66 AND THE SFNE AND CALLED FOR THE UNDERGROUND TO UNITE WITH THE REBEL ARMY AND MILITIA TO PREPARE TO REPUDIATE THE SELL-OUT OF CUBAN SOVEREIGNTY.)</p> <p>2.
