1. ENZEL MET <sup>OR</sup> ~~CO~~COVE DISSIDENT MICHEL YABOR AFTERNOON 26 JULY. YABOR REPEATED PREVIOUSLY STATED DESIRES <sup>OR</sup> ~~CO~~COVE GROUP TO BE RECOGNIZED BY AND WORK WITH FRD. REPEATED PREVIOUSLY STATED <sup>OR</sup> ~~CO~~COVE INTENTIONS PRESS EXCOFF FRD FOR IMMEDIATE RECOGNITION.

2. ENZEL MET ROGELIO GONZALEZ CORSO AT LATTER'S REQUEST EVENING 26 JULY. GONZALEZ REQUESTED BENDER AID (ETHER FALSE DOCUMENTS/ DISGUISE OR MARITIME INFILTRATION) FOR BLACK RETURN CUBA. STATED NEWS HAD JUST REACHED MIAMI OF HAVANA ARREST "LIONEL." (MRR CODE NAME FOR ALFREDO PLIQUE, WHO, ALONG WITH LUIS BARCENA, IS <sup>OR</sup> ~~CO~~COVE GROUP ORGANIZER HAVANA). GONZALEZ SAID WAS CERTAIN <sup>OR</sup> ~~CO~~COVE WOULD ACCUSE HIM AND AMBIDDY-1 OF INFORMING AND WOULD RETALIATE BY INFORMING IN TURN AGAINST HIM (GONZALEZ) IF RETURNED CUBA LEGALLY. ENZEL REPLIED WOULD CONSIDER REQUEST. FOR HAVA: ALSO STATED AMYUM-1 HAD BEEN BRIEFLY ARRESTED ON RETURN HAVA, QUESTIONED AND RELEASED. AS RESULT, HAD TEMPORARLY SUSPENDED CLANDESTINE ACTIVITIES.

3. ENZEL MET ARBIDY-1 AIDE EMMEL GILLOT CASTELLANOS LATE MORNING 27 JULY. GILLOT REPORTED <sup>OR</sup> ENZO DIAZ, NICHOL YABOR, AND CHINEA HAD LOCATED ARBIDY-1 LATE EVENING 26 JULY AT HOME PEPEDA RIERA AND HAD ADMINISTERED SEVERE BEATINGS.

4. MRR DISPUTE HAS DEVELOPED INTO PARTISAN "PUBLIC PROTEST MEETINGS" AND MUTUAL NAME CALLING BY MEANS PAID ADVERTISEMENTS <sup>IN</sup> SPANISH LANGUAGE PRESS. WASH WILL CONTINUE CONCILIATION EFFORTS TO <sup>PRE</sup>VENT FURTHER DEGENERATION SITUATION AND RESILIENT BAD PUBLICITY BOTH MRR AND FRD.
