PASS FOLLOWING MSG IN ENGLISH TO PEXLOK:  
" 20 . BRAND. THIS MESSAGE EXTREMELY IMPORTANT AND  
CONFIDENTIAL. PLEASE TREAT IT WITH UTMOST SECURITY. WE WOULD LIKE  
YOU CONTACT AGENT 2637 AND TELL HIM VERY DISCREETLY THAT WE WANT TO FIND  
OUT WHETHER QUINTERO WAS ARRESTED AT TIME WHEN HIS RADIO SET PICKED UP  
BY G-2. MRR REPORTED QUINTERO WAS IN BAD SITUATION BUT DID NOT GIVE  
DETAILS. NOW MRR WANTS USE QUINTERO AS PRINCIPAL RADIO OPERATOR IN  
HAVANA. WE MUST DETERMINE IF QUINTERO WAS ARRESTED AND RELEASED. YOU  
CAN UNDERSTAND WHY WE CANNOT TELL MRR THROUGH THEIR OWN CHANNEL. ASK  
2637 TO REPORT ON THIS MATTER USING YOUR CHANNEL. IMMEDIATE REPLY IS  
AWAITED."
