OCCAR RODRIGUEZ MOLINA

T-1, on September 1, 1954, furnished the following information [redacted] the files of the [redacted]

OCCAR RODRIGUEZ MOLINA appeared at [redacted] the International Airport at Merida, Yucatan, Mexico, on August 1, 1954, stating that he was a Cuban citizen who desired to return to Cuba. RODRIGUEZ said that he was born in Jaruco, Havana, Cuba, was 31 years old, married, an employee, and had his permanent residence at Calle Galeno 31, Havana, Cuba.

RODRIGUEZ stated that he entered Mexico at the International Airport in Mexico City on January 21, 1951, and was granted political asylum.

RODRIGUEZ presented a certificate of Cuban nationality issued by the Cuban Consulate in Mexico City on July 27, 1951, and also exhibited a similar certificate for his minor son.

RODRIGUEZ stated that the reasons for which he had requested political asylum in Mexico no longer were in effect and he desired to renounce his status of political asylum in Mexico. He stated that he wanted to return to Cuba with his 16-month-old son, OCCAR ENRIQUE RODRIGUEZ.

SANCHEZ, who had entered Mexico on June 23, 1960, accompanied by his mother, MARY SANCHEZ RODRIGUEZ, who is a Mexican citizen.

[redacted] disclosed that RODRIGUEZ first entered Mexico as a political exile on July 1, 1960, arriving from Cuba. He departed Mexico, en route Cuba, on January 3, 1961.

RODRIGUEZ stated he was born in Jardico, Havana, Cuba, on December 10, 1930.

RODRIGUEZ requested permission, prior to departing from Mexico, to marry MARY ALFREDON/SANCHO PRADO, a Mexican citizen; however, RODRIGUEZ did not marry SANCHO in Mexico, but rather married her in Guatemala, Elvano, Guatemala, August 7, 1959.

After the re-entry of RODRIGUEZ into Mexico in January, 1961, he stated that he was a Sergeant in the Cuban National Police until April 4, 1960, at which time he resigned because he did not approve of the operations of the police. He claimed that he then obtained employment as Chief of the Water Pipe Tank Department of the Albae' Landuct in Havana, Cuba, where he remained until September 1, 1960.

He came to Mexico as a tourist at about this time, returning to Havana, Cuba, from Mexico, on November 10, 1960. As a result of this trip, the Cuban intelligence organization, referred to as the G-2, allegedly persecuted him until he was obliged to request political asylum in the Mexican Embassy in Havana, Cuba.

He was authorized to remain in Mexico as a political exile on February 4, 1961, when he was given permission to accept employment as a salesman, since he is married to a Mexican citizen by birth.

On June 23, 1961, Mrs. RODRIGUEZ asked for authority to accompany her son, OSCAR, of Cuban nationality, to the

city of Houston, Texas, stating that her husband was located in that city. (There is no information in the [redacted] to indicate that RODRIGUEZ had left Mexico to enter the United States.)

As mentioned above, RODRIGUEZ appeared at the Immigration office in Merida, Yucatan, Mexico, on August 9, 1931, and departed Merida, en route Havana, Cuba, on August 10, 1931, accompanied by his son, OSCAR.

Mrs. RODRIGUEZ, on September 7, 1932, requested authority from the [redacted] for her husband to enter Mexico as an immigrant. Mrs. RODRIGUEZ stated that MIGUEL MONTERO DE SANCHEZ, owner of the Nueva Xola Pharmacy in Mexico City, had offered him employment at a salary of 900 pesos (\$72 U.S.) monthly.

RODRIGUEZ did not accept this employment, and on February 3, 1933, JUANITO VILLENA, owner of the Versalles Pharmacy, Jalapaes 38, Mexico City, offered RODRIGUEZ employment in that pharmacy at a salary of 1,000 pesos (\$80 U.S.) monthly.

RODRIGUEZ requested authority to enter Mexico,

[redacted] He was admitted as an immigrant for a period of one year, since his wife is a Mexican citizen by birth. He was admitted with permission to accept employment at the Versalles Pharmacy.

RODRIGUEZ entered Mexico at International Airport, Mexico City [redacted]

RODRIGUEZ stated that his residence in Havana, Cuba, is located at Calle 3, between Third Avenue and Final Maranjo, Guanabacoa, Havana, Cuba.

RODRIGUEZ furnished his residence in Mexico City as Sindicalismo No. 37, Apartment 217, Colonia Escandon.
