1. SUBJ REFS CONTACTED VIA UNSNAFU/9 ON 25 MAY, TO REQUEST AID, SUBSEQUENTLY RE. USED ON SECURITY GROUNDS. IN OBTAINING SPANISH VISA AS REPORTED REF A. IN ADDITION TO REF B, FOLLOWING POINTS DISCUSSED WITH MIRRLEES WHO HAD TWO MEETS WITH SUBJ ON 25 MAY, FIRST AT MEET WITH UNSNAFU/9 AND SECOND BAR HOTEL NAPOLEON TO GIVE SUBJ ANSWER ON VISA.

2. SUBJ STATED HAD BEEN IN CONTACT WITH KUBARK 15 TIMES AND 15 TIMES HAD DISSOLVED RELATIONSHIP. STATED KUBARK LAST ATTEMPTED CONTACT HIM NEW YORK VIA ODURGE TWO MONTHS AGO AND THAT HE THEN AGREED TO CONTACT. SUBJ STATED NOT INTERESTED IN CONTACTS WITH LOW-LEVEL TYPES, ONLY HIGHEST PBRIME LEVELS. SUBJ STATED HAD MANY HIGH LEVEL FRIENDS IN PBRIME GOVT. NAMED BOBBY KENNEDY AS ONE WHO ONCE HELPED HIM OUT OF JAM. SUBJ ID TOOK PART MANY RAIDS

3. SUBJ SPOKE IN SAME VEIN OF DISCONTENTMENT OF "NO ACTION" AND OF MADR GROUP, SPECIFICALLY NAMING QUSPORT/1, AS DID ANLASH/3, UNSHAFU/9. AS REPORTED REF B, SUBJ STATED WOULD HAVE QUSPORT/1 KICKED OUT (PRESUMABLY KUBARK) AS SOON AS POSSIBLE. SUBJ AND UNSHAFU/9, AS WELL AS ANLASH/3, HAVE REPEATED EXPRESSED THEIR HIGH REGARD OF BELIEF IN ANLASH/1. NOT THAT ANLASH/3 IS IN PBRIMEN, SUBJ AND UNSHAFU/9 SPEAK OF HIM IN SAME RESPECT AS ANLASH/1.

SAID THEY ARE NOW RISKING LIVES AND ONLY WAY THEY WILL GET OUT OF PBRIMEN WILL BE STEAL ^{IA} PLANE AND ATTEMPT ESCAPE. UNSHAFU/9 HAS STATED SEVERAL TIMES, SINCE APRIL BOTH TO GLOADEN AND MIRREES, THAT "SOMETHING BIG" GOING TO ^A HAPPEN IN NEXT THREE MONTHS. SUBJ AND UNSHAFU/9 BOTH STATED TIME IS RIPE FOR ACTION.

4. SUBJ ARRIVED IN PARI FROM LOND ON 21 MAY. WHEN MIRREES ASKED SUBJ WHY HIS KUBARK CONTACTS IN PBRIME HAD NOT PROVIDED NECESSARY ARRANGMENTS FOR VISA, SUBJ STATED HIS BUSINESS MADR NOT KUBARK SPONSORED AND KUBARK NOT AWARE OF IT. SUBJ INSISTED IT IMPERATIVE HE ARRIVE MADR 25 MAY TO SPEAK TO "IMPORTANT MEMBER THEIR GROUP." SUBJ SAID ALSO SHOULD HAVE BEEN IN ZRNITAL BY 25

BY SO IF KUBARK [] COULD NOT OBTAIN VISA HE WOULD HAVE TO RETURN
PBRPIME AND FROM THERE RETURN MADE LATER DATE. SAID THIS COMPLI-
CATES HIS PLANS. SUBJ SOUGHT KUBARK ASSISTANCE ONLY AFTER NORMAL
VISA APPLICATION DETERMINED TO TAKE TOO LONG.

5. WHEN MIRRELES HAD SECOND MEET WITH SUBJ TO CONFIRM RESULTS
OF ^{TAL} [] WITH STOCKWOOD RE VISA (MIRRELES FIRST TOLD ^{LD} SUBJ SHE WOULD
CHECK WITH HER BOSS BUT CERTAIN WOULD BE DENIED ON SECURITY GROUNDS)
TWO FRIENDS OF SUBJ APPEARED: MAN NAMED "FRANK" APPROX 25-29
STATED HAD KNOWN SUBJ LONG TIME. GIRL "DANIELLE" APPROX 24 DID
NOT SPEAK. BOTH APPEARED BE STUDENTS. MAN APPEARED APPROPRIATE.
SUBJ PROPOSED MIRRELES JOIN GROUP FOR DINNER BUT MIRRELES DECLINED
OFFER AS HAD OTHER PLANS.

6. FROM ABOVE, IT OBVIOUS THERE TWO DIFFERENT STORIES RE KUBARK
CONTACT WITH SUBJ. SUBJ'S LINE OF THOUGHT EXACTLY, ALMOST TO SAME
WORDS, AS THAT OF AMLASH, UNSNAFU/9.

7. REGARDING PARA TWO REF A, [] NOT AWARE COMMENT THIS SUBJECT
IN GROUPS NOT ALREADY CONNECTED WITH AMLASH ONE. FROM HERE PROB-
LEM SEEMS BE THAT AMLASH CIRCLE IS WIDE AND EACH NEW FRIEND OF WHOM
WE LEARN SEEMS TO HAVE KNOWLEDGE OF PLAN.
