SUBJECT: BUSTAMANTE y O'Leary, Jose Angel

1. Reference is made to your NY memorandum 70-80, dated 20 May 1955, subject as above, whose name you desired checked against the files of this office.

2. The files of this office contain the following information concerning the subject of your request.

3. In a communication dated 21 February 1949 from a usually reliable source, Jose Angel BUSTAMANTE, Secretary-General of the Second Pan American Medical Congress held at Lima, Peru, in February 1949, was described as a "strong" Communist. Additional information contained in a communication dated 23 February 1949 from a usually reliable source, indicated that Jose A. BUSTAMANTE was a member of the Medical Section, Committee of the Institute of Cuban-Soviet Cultural Inter-exchange. The communication further indicated that a sub-source of unknown reliability speculated that the above-mentioned medical congress was under Communist influence.

4. Information (possibly already known to the Department) concerning Subject was forwarded to the Immigration and Naturalization Service in CS 10-6791, dated 29 June 1953, subject: Jose Angel BUSTAMANTE O'Leary, a copy of which is transmitted herewith.

5. For supplementary information concerning Jose Angel BUSTAMANTE y O'Leary, the subject of your request, and concerning one Jose BUSTAMANTE, the name identical with Subject, the Department is referred to the following:
