1. SUBSEQUENT 7 OCT INTERVIEW AMCLATTER-1 WITH ODEVY, HE RETURNED MIAMI WITH AMCLATTER-6. BOTH MET WITH ODEVY AND DEBRIEFED RE [REDACTED] REGISTRAR PEREZ JIMENEZ OFFICE.

2. WHILE IN MIAMI BOTH AGENTS DISCUSSED CASE WITH ODEVY INFORMANT [REDACTED] PROBABLY IDENTICAL WITH UNIDENTIFIED ODEVY INFORMANT MENTIONED REF. ON 5 NOV ODEVY REPORTED [REDACTED] FIRED BY PEREZ JIMENEZ, ADMITTED TO ODEVY SEE PLANTED LATER'S OFFICE AS PART KIDNAP PLOT.

3. [REDACTED] CLAIMS [REDACTED] INFORMED CESAR E. GAMBACHO COVANI, FORMER JUSTICE MINISTER UNDER BRYISTA, THAT [REDACTED] WRITING TO BAYO. GAMBACHO QUESTIONED [REDACTED] ABOUT LETTERS. [REDACTED] DENIED WRITING BAYO, BUT FIRED PRESUMABLY BECAUSE GAMBACHO INFORMED PEREZ OF ACCUSATION.
