1. AMLASH ONE AND AMWHIP ONE DEPART STOC FOR COPE 10 AUG SAS 437. [REDACTED] FOLLOWING. SUBJ TO FRAG ABOUT 11 AUG, THEN PARI 13 OR 14 AUG. AMWHIP AND PARI EVENING 12 AUG. MEETING ARRANGEMENTS PARI LAID ON.
2. FEEL ADVISABLE KUBARK BUSINESS WITH SUBJ TAKE PLACE PARI ASAP AS SUBJ'S FRIENDS HARD TO SHAKE ONCE THEY LEARN HIS PRESENCE. ADVISE SOONEST PARI ETA C/O PER REF, WHO CAN CONTACT F WINTERGURST'S OFFICE WBFINCH.
3. SUBJ MORE RELAXED NOW. OTHER ASSESSMENTS STILL VALID. BELIEVE SUBJ NOW MORE WILLING LISTEN KUBARK OPS SUGGESTIONS, HOWEVER HE VERY TEMPERMENTAL AND FEEL CAPABLE ABRUPT DECISION DROP WHOLE IDEA AND SETTLE PARI OR ELSEWHERE. THIS UNLIKELY UNLESS KUBARK PLANS HIS USE SO MINOR OR INDECISIVE HE FEELS RISK NOT WORTH IT, OR IF SECURITY AGREEMENT RE WAVE CUBANS VIOLATED.
