1. PLEASE CABLE NAME AND ANY ADDITIONAL PERSONAL DETAILS SUBJ REF. STATION ASSETS CAN TRY GET PARA 2 REF INFO.
2. AS SUBJ WILL HAVE FINNISH VISA HE CAN TRAVEL TO OTHER SCANDINAVIAN COUNTRY ON OWN PASSPORT. HOWEVER SECURITY BETTER IF SUBJ EVACUATED WITH ALIAS DOCUMENTATION. SUGGEST HQS INFORM MKTOPAZ SOONEST ORDER PREPARE ALIAS DOCS IF LATTER COURSE TAKEN.
3. STATION HAS NO CONTROLLED PRESS CONTACT BUT SINCE TPPAPMEAT WILL HAVE PRESS OFFICE DURING ZRPENNY PRESS CONFERENCE AND DETAILS COULD BE WORKED THROUGH CHINDELAS WHO IN CHARGE.
4. WILL SUBJS FRIEND ESCORT HIM AND OBIVIATE NEED CASE OFFICER FOR EVACUATION PHASE? IS HQS C/O COMING AND WHAT ASSISTANCE WILL HE NEED?
5. DO NOT FEEL VACHAP/1 CAN HELP IN THIS CASE. HE PROBABLY ABLE GET PLANE RESERVATIONS ON STUDENT FLIGHT BUT WE FEEL THIS MAY UNNECESSARILY INVOLVE HIM AND HIS GROUP. WITH ENOUGH LEAD TIME PLANE RESERVATIONS SHOULD NOT BE DIFFICULT.
