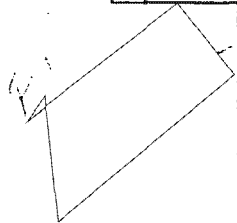

OUT OF CONCERN FOR SUBJECTS SECURITY SUGGEST DEFECTION BE SURFACED BY EXCLUSIVE INTERVIEW THROUGH CONTROLLED PRESS CONTACT [redacted] WHO CAN BE PERSUADED HOLD STORY FOR SEVERAL HOURS PENDING SUBJECTS DEPARTURE TO STOC OR COPE WHERE HOPFULLY MORE UNRESTRAINED PRESS COVERAGE CAN BE OBTAINED FOR IMMEDIATE FEED BACK TO [redacted] IDEALLY SURFACING WITH PRESS SHOULD BE TIMED INFLUENCE VOTING FINAL ZRPENNY RESOLUTIONS.
2. HQS WAVE PREPARING CONTACT AND DISPATCH PBPRIME RESIDENT FRIEND SUBJECT TO ASSIST DEFECTION. REQUEST [redacted] TRY DETERMINE WHETHER SUBJECT ON ZRPENNY PREPARATORY COMMISSION, WHEN HE ARRIVING HELS AND WHERE HE STAYING. ADVISE CAPABILITY. SUBJECT CAUCASIAN, BUT WHEN LAST SEEN WAS BEARDED.
