LETTER WAS ORIGINALLY PREPARED FOR SENDING VIA OTHER CHANNELS, BUT REF TRIP MORE EXPEDITIOUS.

TELEPHONE 80 32 09 OR 86 07 10. AMWHIP PERSONAL FRIEND AND BUSINESS ASSOCIATE OF FIRM'S OWNER, SIGNOR CORLETTO.

3. HEALTH PERMITTING, SUGGEST GROVERLY CALL AMWHIP AND DOUBLE TALK REQUEST. IF UNABLE, OTHER STAFFER SHOULD ATTEMPT CALL, IDENTIFYING SELF AS "FRIEND OF BILL THOMPSON". FYI AMWHIP NOT EXPECTING CONTACT EUROPE AT THIS TIME BUT BELIEVE ABOVE WILL
