1. A FORMER CUBAN NATIONAL WHO WAS IMPRISONED AT COMBINADO DEL ESTE PRISON IN HAVANA UNTIL HIS RECENT DEPARTURE FOR THE U. S. REPORTED THE FOLLOWING INFORMATION CONCERNING OTHER PRISONERS:

A. BRIGADE 2506 MEMBERS RICARDO M O N T E R O DUQUE AND (FNU) VILLAYERDE ARE IN THE COMBINADO DEL ESTE PRISON. HE HAS HEARD THAT TWO OF THE BRIGADE 2506 VETERANS (NAMES UNKNOWN) HAVE DIED IN PRISON AND THAT FIVE OTHERS (IN ADDITION TO MONTERO AND VILLAYERDE) ARE STILL IN PRISON, BUT HE DOESN'T KNOW THEIR NAMES.

B. ROLANDO C U B E L A, A FORMER CASTRO AMBASSADOR, IS IN COMBINADO DEL ESTE FOR ALLEGED ANTI-CASTRO ACTIVITIES. HOWEVER, HE IS SERVING AS AN INFORMANT FOR PRISON AUTHORITIES ON THE ACTIVITIES OF THE POLITICAL PRISONERS.
