IRVING DAVIDSON, SUBJ OF LEWIN/MAY CALL, PURCHASING AGENT FOR NICARAGUAN GOVT CURRENTLY OBJECT OF INTEREST DUE TO HIS RESALE TO CUBA OF ISRAELI ARMORED CARS PURCHASED BY NICARAGUA. CUBAN NAVY FRIGATE USED IN CUBAN SHIPMENT BELIEVED SEAWORTHY FOR PACIFIC CROSSING AND POSSIBLY IDENTICAL SHIP DESCRIBED THIS CONVERSATION. TWENTY THOUSAND FIGURE CITED APPEARS APPLY TO SMALL ARMS. NOW QUERYING NICARAGUA IF SMALL ARMS INCLUDED IN PURCHASE FROM ISRAEL AND FOR EVIDENCE SMALL ARMS IN THAT APPROXIMATE VOLUME BEING PREPARED FOR SHIPMENT OUT.
