<p>The following is a summary of a recent report prepared by QMREPORT/1 concerning his contacts with AMASH/1 in Madrid and developments concerning AMASH/1 and ANALYST/1:</p> <p>1. QMREPORT/1 was contacted by ANALYST/1 in Madrid on 7 December 1964 and told:</p> <p class="list-item-l1">a. The places they had made in New York to get AMASH out of PERU for a meeting were no longer necessary since he had come out via Prague-Paris.</p> <p class="list-item-l1">b. He was very cynical about his meeting with AMASH/1 because:</p> <p class="list-item-l2">(1) AMASH/1 definitely counts on at least 5 commandos and many other officers for the coup.</p> <p class="list-item-l2">(2) AMASH/1 himself is again active in the Army with the help of Raul Castro.</p> <p class="list-item-l2">(3) The situation in PERU is deteriorating and the right moment for the coup lies in the next few months.</p> <p class="list-item-l2">(4) AMASH/1's morale is high and he plans to return to PERU soon.</p> <p class="list-item-l2">(5) ANALYST/1's people have contacted AMASH/2 and AMASH/3 in Madrid and knowing that "something was going on inside PERU with a big Communist involved" (both said they did not give any names), ANALYST/1's people were so excited over this that ANALYST himself was coming to Europe. (He arrived in Rome 2 or 3 days later).</p> <p class="list-item-l1">c. ANALYST/1 was offering:</p> <p class="list-item-l2">(1) Any amount of small weapons and money for a big operation.</p> <p class="list-item-l2">(2) A well trained group of men.</p> <p class="list-item-l2">(3) A small size air force and navy.</p> <p class="list-item-l2">(4) Any sort of military action as complement of the coup inside.</p> <p class="list-item-l2">(5) Immediate diplomatic recognition of at least six Latin American Governments principally in Central America.</p> <p>d. ANALYST/1 would like to speak with QMREPORT and they should take the next plane for Paris.</p> <p>2. QMREPORT told ANALYST/1 everything was all right except for three points:</p> <p class="list-item-l1">a. ANALYST/1 was offering <u>support</u> <del>support</del> <u>elsewhere</u> help - KUBAK.</p> <p class="list-item-l1">b. They can get this help anytime without ANALYST/1 or ANALYST.</p> <p class="list-item-l1">c. ANALYST/1 needs very little without this help.</p> <p>3. QMREPORT/1 will be then suggested ANALYST/1 inform KUBAK immediately what anal-</p>

AMBIDY/1 was coming to Europe to see him. This apparently "Nick" did not do because the following day AMBIDY/1 phoned AMIASH/1 in Paris to get his decision regarding the meeting with AMIASH/1. AMIASH/1 told AMBIDY/1 over the phone that he knew nothing about the meeting. AMBIDY/1 then took the next plane for Paris and later phoned QUASPORT/1 to tell QUASPORT that AMIASH/1 had decided not to meet with AMBIDY/1 for the present. AMBIDY/1 then left for New York City via Rome.

5. In the meantime AMBIDY/1 had come to Rome with three of his men apparently determined to see AMIASH. He sent Idea A to Madrid. Idea A told QUASPORT/1 that AMBIDY/1 would like to speak with either AMBIDY/1, AMIASH/1 or QUASPORT/1 but that he could not come to Spain legally because of the Sierra Aranizcu incident. QUASPORT/1 told Idea A that AMBIDY/1 was in New York City and ~~AMBI~~/1 had no intention of meeting with AMBIDY/1, at least for the present, and that a conversation with QUASPORT would not change anything. AMBIDY/1 insisted on trying to see AMIASH/1 and went to Paris with two of his men, one of whom is Idea B.
6. On 21 December QUASPORT received a letter from AMBIDY/1 in New York telling QUASPORT:
  - a. AMIASH/1 did not want to meet with AMBIDY/1 because of security.
  - b. AMIASH/1 will return to PB ROME at the end of January 1963.
  - c. AMIASH/1 has a fixed idea of what the solution is to the PEFRDE problem.
  - d. AMBIDY/1 was coming to Europe shortly and he hoped the three of us could get together.
7. AMIASH/1 phoned me from Paris on the 22nd of December to tell me he would be here on 26 December and that he would try to stay at the Embassy. QUASPORT told him about AMBIDY/1's letter.
8. On 22 December AMBIDY/1 phoned me (QUASPORT/1) and told me the following:
  - a. A meeting of all forces is necessary.
  - b. To tell AMIASH/1 that the "Americans" want to take him for the immolation (sic) and that with the failure of the Bay of Pigs he, AMBIDY/1, had had a very bitter experience, that was paid off in blood and jail and all because of the inconsistencies of American Policy.
  - c. That he has under his own control the necessary forces to produce, together with AMIASH/1, a definite action without any outside help and even against anyone's will.

  - d. He was going back to PEFRDE for a few days on the 23rd of December to clarify a few things and then back to Paris.
  - e. That regardless of AMIASH/1's decision he wants to speak with QUASPORT/1 anyway.
  - f. That he was sending Idea A to Madrid on 23 December as his contact man.
9. QUASPORT/1 summed up his opinion as follows:
  - a. Regardless of whatever explanation is given, the situation is out of control.
  - b. In view of all the circumstances I do not think AMIASH/1 can go on much longer with this conspiracy without taking some definite action or being discovered and I feel that AMIASH/1 knows it.
  - c. I feel this is the moment to reconsider the whole business and come out with some specific plans to be worked out soon.
