A. SAME SUBJS REF B, MET WITH ANWORM-1 IN HOME MOTHER OF 201-759879. PURPOSE OF MEET WAS TO ENABLE ANWORM-1 TO PROVE TO IDEN-1 REF B THAT ANWORM-1 HAD CONTACTS DESCRIBED REF A. (IDEN-1 REF B SKEPTICAL ABOUT ANYTHING ANWORM-1 SAYS DESPITE FACT THEY FRIENDS). MOTHER OF 201-759879 WIDOW AND LIVES ALONE AT IDEN.

B. MOTHER ASKED ANWORM-1 RE PRESENT LOCATION AND HEALTH OF SON AND WHY HAD NOT COME PBPRIME. MOTHER CLAIMS SPENT CONSIDERABLE MONEY GETTING VISA FOR SON AT HIS REQUEST AND DISAPPOINTED HE NOT ARRIVED YET.
