| <p><b>ACTION: See paragraph 5</b></p> <p>1. At a 20 August 1965 meeting ANWHIP/2 was asked about a series of PERUMENs (15 in all) who, he was told; are or have been in Rome. Included in the list at intervals were ANLASH/1, 2, and 3. (BUNCE Comment: In accordance with a discussion with LANGOSCH during his recent trip to Rome.) ANWHIP/2 was given no further information and nothing about the fifteen men except their names.</p> <p>a. Subject did not respond re ANLASH/3.</p> <p>b. Subject had heard ANWHIP/1 and others mention ANLASH/2, whom Subject does not know personally. He knew of him only that he had been in Paris a number of times and that he was said to be stupid.</p> <p>c. Subject knows ANLASH/1 well, although not as well as does ANWHIP/1, through whom ANWHIP/2 met ANLASH/1. Subject described ANLASH/1 as a very complicated person of confusing and perhaps confused loyalties. Once, when ANLASH/1 was so drunk and ill that he was heading for the bathroom to vomit, he kept shouting curses at the ANTHUG regime which "murdered my son." Sober, he is also critical of ANTHUG. But as soon as anyone else is similarly critical, ANLASH/1 immediately defends ANTHUG and his government. ANWHIP/2 believes that ANLASH/1 is emotionally and psychologically mixed up and does not know where he stands.</p> <p>d. ANWHIP/2 knows why ANWHIP/1 and ANLASH/1 met. (He did not state the reason and was not asked.) He knew, however, only through what ANWHIP/1 volunteered, and not through being present at any meetings. When these occurred, if ANWHIP/2 chanced to be present, he left the room voluntarily and at the outset.</p> |                            |                       |   |
