1. BACKGROUND THIS CASE TOO EXTENSIVE TO RELAY. HOWEVER, PLAN HAVE JOSEPH LANGOSCH, WHO BEING ASSIGNED FRAN AS PBRUMEN REGIONAL REP, VISIT [redacted] TO BRIEF PRESLAND, PROBABLY IN AUGUST.

2. NO DEFINITE EVIDENCE AMLASH COMPLEX PART OF DOUBLED OP BUT CERTAINLY AN INSECURE ONE. REF A WAS DESIGNED TO PRESENT CURRENT HQS THOUGHTS AND INTENTIONS ON OPERATION.

3. INVOLVEMENT AMWHIP/2 RELATIVELY MARGINAL AS HE APPEARS BE *ONLY* FRINGES OF MAIN GROUP *Thought probably* AND NOT PRIVY TO PLANS. HOWEVER, UNLESS [redacted] HAS SPECIFIC OPS PLANS INVOLVING HIM WHICH MUST BE IMPLEMENTED NEAR FUTURE, SUGGEST CONTACT WITH HIM BE MINIMIZED UNTIL LANGOSCH CAN PROVIDE BACKGROUND.
