1. GROWERY HAD A MEETING WITH ANLASH 3 NIGHT 9 APRIL WHICH SET UP BY QUSPORT. AT MEETING ANLASH 3 LOANED GROWERY 6 POSITIVE MINIATURE PRINTS NOTED PARA 20 REF A (NOT MICROFILM) WHICH PHOTOGRAPHED AND RETURNED 10 APRIL.

2. IN SUMMARY ANLASH 3 SAID HE AND ANLASH 2 HAVE BEEN ON ANBIDDY/ ANWORLD PAYROLL AT \$250 A MONTH EACH SINCE LAST OCTOBER MEETING IN PARI WITH ANWORLD REPS AND STILL RECEIVING SALARY. HE SAID IN ADDITION HELPING ANBIDDY GET TOGETHER WITH ANLASH 1 TO COORDINATE EFFORT AGAINST CASTRO HE WAS ALSO TO GO ANWORLD TRAINING CAMPS SANTO DOMINGO AND LATIN AMERICA AND REPORT TO ANBIDDY ANY CASTRO PENETRATIONS.

3. ANLASH 3 SAID HAD NO CONTACT WITH CUBAN G-2 SINCE ARRIVAL MADRID SEPTEMBER 64 UNTIL LUIS MANUEL CANTILLO ARRIVED HERE ASSIGNED AS SECOND SECRETARY OF CUBAN EMBASSY IN NOVEMBER 64. ANLASH 3 SAID HE KNEW CANTILLO IN CUBA AND THAT HE IS G-2. SHORTLY AFTER

HIS ARRIVAL, CANTILLO CONTACTED AMLASH 3 AND OFFERED HIM MONEY (WHICH HE SAYS HE REFUSED), BUT SAID HE HAD NO MISSION FOR HIM IN SPAIN OTHER THAN KEEPING AN EYE ON EXILES. WHEN AMLASH 3 TOLD CANTILLO ABOUT HIS ASSIGNMENT FOR AMBIDDY 1, LEAVING OUT HIS REPORTING ROLE ON CASTRO'S PENETRATIONS (SO HE SAYS) CANTILLO SHOWED INTEREST.

4. IN JANUARY 65 WHEN AMLASH 1 WAS IN MADRID, AMLASH 1, AMLASH 3, QUHOPS 1, CANTILLO AND AN UNIDENTIFIED CUBAN ARMY MAJOR HAD DINNER TOGETHER ON THE OUTSKIRTS OF MADRID. AMLASH 3 CLAIMS THIS MAJOR, WHO USED THE NAME "JESUS" WHILE HERE, WAS A FORMER MEMBER OF THE 26 JULY MOVEMENT IN N.Y.C. BEFORE BATISTA WAS OVERTHROWN, AND KNOWN THERE AS "HARRY". AMLASH 3 DESCRIBED HIM AS 5'6", DARK, APPROXIMATELY 140 POUNDS, WITH MUSTACHE. ACCORDINGLY AMLASH 3, THIS MAJOR ARRIVED MADRID VIA PRAGUE AND PARI, AND RETURNED PARI FROM MADRID. THE MAJOR ACTIVATED AMLASH 3 FOR G-2 ASSIGNMENT IN SANTA DOMINGO TO REPORT ON AMWORLD ACTIVITIES. HE GAVE HIM 5 MINATURE PHOTOS CONTAINING COMMO AND OTHER INSTRUCTIONS WHICH WERE CONCEALED BETWEEN THE COVERS OF A SMALL LEATHER DIARY PRINTED IN MEXICO, AND \$500 IN U.S. \$20 BILLS. AMLASH 3 SAYS CANTILLO WAS PRESENT DURING THIS MEETING AND HE TURNED \$500 OVER TO CANTILLO TO KEEP UNTIL HE LEFT ON HIS MISSION. AMLASH 3 ALSO CLAIMS MAJOR GAVE HIM CONTACT INSTRUCTIONS

IN CASE HE WENT N.Y.C. IF IN N.Y. HE IS TO WAIT IN LA BARACA RESTAURANT IN N.Y.C. EVERY FRIDAY NIGHT BETWEEN 9-11 P.M. HE WILL BE APPROACHED THERE BY SOMEONE HE RECOGNIZES IN THE NAME OF "EDUARDO".

5. AMLASH 3 ALSO CLAIMS HE RECEIVED 3 DECEPTION REPORTS FROM AMBIDY WITH INSTRUCTIONS TO PASS ON TO G-2 THROUGH CANTILLO TO ESTABLISH BONA FIDES OF AMBIDY CONTACT, WHICH HE SAYS HE DID.

6. HE SAID HE WAS PREPARED GO SANTO DOMINGO ON MISSION, THAT HIS LOYALTY IS WITH AMLASH 1 AND THAT HE DID NOT PLAN TO REPORT ANY INFO TO CUBAN G-2 WHICH WAS NOT AUTHORIZED BY AMLASH 1 THROUGH AMBIDY. HOWEVER, LATE FEBRUARY HE RECEIVED WORD THAT HIS REQUEST FOR VISA TO ENTER SANTO DOMINGO HAD BEEN REFUSED. HE SAID HE WAS TOLD DURING PHONE CALL TO MIAMI THAT VISA WAS REFUSED ON ORDERS OF KUBARK AND ALSO TOLD LOCALLY BY HERNAN HENRIQUES LORA (201-303500). WHEN HE TOLD CANTILLO ABOUT VISA REFUSAL AND WHY, CANTILLO SAID HE WOULD INVESTIGATE. SINCE THEN CANTILLO HAS BEEN TRYING TO CONVINCHE HIM RETURN CUBA.

7. AMLASH 3 SAID HE WAS ALSO UNDER PRESSURE FROM QUOTA OFFICER (IN QUOTA 46'S OLD SECTION) TO COOPERATE IN THE COVERAGE OF CANTILLO AND OTHER CUBAN EMBASSY OFFICERS. HE FEARS HE WILL BE ORDERED TO LEAVE SPAIN IF HE CONTINUES TO REFUSE. HE HAS TOLD CANTILLO HE

"MAY HAVE TROUBLE WITH THE SPANIARDS" AND CANTILLO SAID TO LET HIM KNOW IMMEDIATELY AND HE WOULD ARRANGE FOR AMLASH 3'S TRAVEL TO PARI-PRAGUE-HABANA.

8. AMLASH 3 SAYS THAT AS FAR AS HE IS CONCERNED HE CAN RETURN TO HABANA, AND IF NOT GIVEN A JOB THERE WITH SECURITY HE WOULD SEEK AMLASH 1'S ASSISTANCE.

9. AMLASH 3 MADE NO PITCH FOR FINANCIAL OR VISA ASSISTANCE AT MEETING AND NO COMMITMENTS MADE TO HIM. QUHOPS 1'S NAME CAME UP SEVERAL TIMES BUT NO NEW SIGNIFICANT INFO DEVELOPED. ACCORDING AMLASH 3 QUHOPS 1 PLANS RETURN CUBA SOON AND HAS NO INTEREST TALKING TO PBPRIMERS.

10. UNDOUBTEDLY AMLASH 3 WILL TRY REACH US AGAIN THROUGH QUSPORT BUT IN ANY EVENT PLAN FOLLOW UP THIS CONTACT WITHIN REASONABLE PERIOD TIME TO EXPLORE POSSIBLE AMLASH 3 UTILIZATION AGAINST CANTILLO AND OTHER EMBASSY PERSONNEL AS WELL AS POSSIBILITY HIS RETURN CUBA.
