1. ON 25 AUG AMCALL 1 REPORTED FOLL ADR DEVELOPMENTS:

A. MANOLO RAY HAS AGREED TO JOIN THE ADR AND IN DOING SO HAS PLACED DRA. ELENA MEDEROS, JORGE BERUFF AND FNU BARROSO ON NATIONAL DIRECTORATE. RAY HAS INHERITED RAUL CHIBAS FORCES (ALSO KNOWN AS SALVAD) AND ALSO WORKING CLOSELY WITH OPPOSITION GROUP LASALVAR, A CUBA (SAC). RAY WANTS RUF0 LOPEZ FRESQUET PLACED ON NATIONAL DIRECTORATE SO AS TO NEUTRALIZE HIM, FEELING THAT HE COULD DO ADR HARM IF NOT INCLUDED.

B. ANTONIO FERNANDEZ NEIVA, ADMINISTRATOR OF COLON PEMETERY IS ADR'S CONTACT MAN WITH JOSE MIRO CARDONA. ADR HOPES DETERMINE IF MIRO WILL BE FRONT MAN FOR ADR WITH A VIEW TOWARD HIS EVENTUALLY WORKING WITH AMRASP.

C. FAUSTINO PEREZ NOW IN ORIENTE PROVINCE WORKING WITH INRA. HE BEING WATCHED BY G-2.

2. AM-1 AGAIN CONTACTED STATION CUTOUT BINIARIS 26 AUG TO ADVISE THAT REF A DEPARTURE HAD BEEN ADVANCED TO 3 SEPT. AM-1 ALSO REPORTED THAT FERNANDES NUEVA, PARA 1 B ABOVE, HAD TALKED WITH MIRO 25 AUG. MIRO STATED HE GOING TO PUERTO RICO TO TEACH, WOULD COOPERATE WITH ADR IN ANY WAY POSSIBLE, BUT FELT AMWAIL WOULD OPPOSE HIS PARTICIPATION IN AMRASP IN WHICH CASE MIRO WOULD RETIRE FROM ADR IN INTEREST NOT WANTING TO JEOPARDIZE ADR INCORPORATION INTO AMCIGAR.
