40,000 - MONEY NOT YET FORHCOMING. CUBANS ALSO BROUGHT UP VERY OLD CASE NOT RECENTLY DISCUSSED BY AMECRU-1 WITH THEM. SAID THEY WOULD ACCEPT 80,000 IN CASE OF SON OF JOSE LUIS DEL POZO.

2. AMECRU-1 CLAIMS ALREADY HAVE ARRANGED SPANISH VISA FOR AMPANIC-7 THRU CONTACT IN FOREIGN OFFICE IN MADRID. WHEN ASKED IF BAUDILLO CASTELLANOS COULD BE TAKING A CUT FROM RANSOM AMECRU-1 SAID MOST NEGOTIATIONS HAVE BEEN IN PRESENCE OF BOTH BAUDILLO AND DIAZ VIGO ELIMINATING SUCH POSSIBILITY. 4. WACHAL BROUGHT UP CASE AMSOUR-1 ALONG LINES REF A.
