1. GORDON M. BINIARIS REPORTS THAT AMSIGH-2 RECEIVED TELEGRAM FROM AMECRU-1 ON 15 FEBRUARY ADVISING THAT RELEASES OF AMPAHIC-7, AMRIPE-2 AND JORGE VILLAVERDE LAMADRIZ HAVE BEEN APPROVED BY CUBANS BUT THAT FINAL AMOUNT RANSOM EACH CASE NOT YET AGREED. FIGURE TO BE AGREED UPON AT NEGOTIATING SESSION SCHEDULED 19 FEB. TELEGRAM ALSO ADVISED THAT CUBANS HAVE NOT APPROVED AMCALL-1 RELEASE, CLAIMING "FURTHER INVESTIGATION" NECESSARY.
