B. ON RETURN TO EUROPE SAW AMKNAR-1 EARLY JULY.

A).THOUGH AMECRU-1 HAD SENI REPEATED REMINDERS TO AMKNAR-1 AND COLLEAGUE AS WELL AS TO IDENTITY A DIRECTLY, NO WORK RECEIVED.

AMKNAR-1 ADVISED THAT BOTH IDENTITY B AND IDENTITY C (MAN WHO INTRODUCED IDENTITY B AS AMECRU'S CONTACT) HAD BEEN TRANSFERRED PCS HAVANA; WITH NO REPLACEMENT INDICATED. ONE WEEK LATER AMKNAR-1 INFORMED HIM THAT HE HAD RECEIVED INSTRUCTIONS FROM HAVANA TO TELL HIM THAT GOC HAD DECIDED TO "RESCIND" OPERATION AND THAT MONEY WOULD BE REFUNDED IN MANNER TO BE DECIDED BY AMECRU-1. NO REASON FOR REVERSAL GIVEN BY AMKNAR-1. HE SAID THAT AMCALL-1 AND AMHINT-3 ACCEPTANCE OF REHABILITATION SHOULD PUT THEM IN GOOD STEAD FOR FUTURE. ON LEAVING, AMKNAR-1 TOSSED OUT COMMENT THAT AMECRU-1 MIGHT BEST CONTINUE TO PURSUE EXCHANGE ISSUE WITH VEREZUELA AND VATICAN.
