1. HORACE N. BIRGELIS ADVISED ON 2 AUGUST 1971 THAT WIFE OF AMCALL-1 CONTACTED AMECRU-1 BY TELEPHONE IN HOME OF VANISTENDAEL IN BELGIUM ON 31 JULY. SHE TOLD AMECRU-1 THAT SHE SENT AIR MAIL SPECIAL DELIVERY LETTER TO HIS BAD NEUHEIM HOTEL GIVING HIM INSTRUCTIONS ON DEPOSIT OF \$70,000 MONEY ADVANCED HER BY "CHURCH FRIENDS." SHE THEN GAVE HIM REF C BANK ACCOUNT NAME AND NUMBER. BEFORE SHE COULD GET TO CRUCIAL QUESTIONS, AMECRU-1 TOLD HER THAT THERE WOULD BE NO PROBLEM WITH HER REQUEST AND THEN THANKED HER FOR SENDING LETTER. THROUGH DOUBLETALK AMECRU-1 LET HER KNOW THAT TELEPHONE WAS NO PLACE TO HOLD CONVERSATION ON "THIS IMPORTANT MATTER."

2. WHEN WIFE OF AMCALL-1 ADVISED AMSIGH-2 OF ABOVE, HE TOLD HER TO CALL AMECRU-1 BACK AT BAD NEUHEIM
