2. WIFE OF AMCALL-1 STATES \$10,000 REF B EXPENSE MONEY NEVER POSTED BY VANISTENDAL BECAUSE HE WAS TO RECEIVE THIS MONEY FROM FRIEND WHO LATER DIED BEFORE IT COULD BE POSTED. AS STATED IN REF B, MONEY WAS REPEAT WAS TO BE POSTED.
