GREETINGS. THANK YOU FOR YOUR TELEPHONE CALL, LETTER & NEWS. LETTER FOLLOWS SHORTLY. MEANWHILE HERE IS DATA ON MAHEU:
 - A. ROBERT MAHEU ASSOCIATES OF 1125 19TH ST NW WASHINGTON D.C. IS SMALL PR FIRM (NOW ABOUT 4 STAFF OFFICERS IN MAIN OFFICE PLUS SUB OFFICES IN LOS ANGELES AND HOUSTON & CONSULTANTS) ESTABLISHED 1952. FIRM ENGAGED PRIMARILY IN PR TROUBLE SHOOTING HANDLING SPECIFIC PROBLEMS RATHER THAN STRAIGHT PR PLACE MENT OF TEEES IN MEDIA. ALSO OCCASIONALLY DOES PART TIME INVESTIGATIVE WORK. HAS SOME GOOD ACCOUNTS. MAHEU IS FORMER FBI MAN AS ARE SOME ASSOCIATES, HAS GOOD REPUTATION AND CREDIT RATING. MAHEU APPEARS BE INTELLIGENT AND HONEST, HAS GOOD CONTACTS. NO KNOWN DEROG CONNECTIONS.
 - B. PLEASE NOTE THAT IT IS BEYOND THE CAPABILITIES OF MY ORGANIZATION TO SUGGEST PROPAGANDA LINES FOR USE BY ANY PR ORGANIZATION IN THIS COUNTRY. I KNOW YOU ALREADY UNDERSTAND THE REASONS FOR SUCH RESTRICTIONS.
