MORNING 22 DECEMBER SERGIO ROJAS SANTAMARIA FORMER CUBAN AND TO ENGLAND CALLED LITAMIL-1 BY PHONE FROM MIAMI AND REQUESTED URGENTLY 2323 DOLLARS U.S. ORDER HELP PURCHASE BOAT FOR LANDING OPERATION AGAINST CUBA SOONEST. ROJAS AFFILIATED RICARDO DE LA LORIE, NINO DIAZ, ANTONIO MICHEL YABUR AMONG OTHERS MRR. APPARENTLY EVERYTHING READY BUT ACQUISITION BOAT.
2. LITAMIL-1 CALLED CO AND REQUESTED ASSISTANCE OPERATION WHICH WOULD BE EXPLAINED BY LITAMIL-5 AT SCHEDULED MEETING LATER IN MORNING.
