- ON 1 MARCH LEOPOLDO ARENAL BASTAR WENT OFFICE LITAMIL-1 WITH REQUEST L-1 ALLOW HIM TAKE 34 BOXES TO HIS [ ] ORDER WIRE STRAP. SHIPMENT. BOXES CONTAIN RADIOS CITED PREVIOUSLY REF B.
- L-1 REFUSED ARENAL SAYING ALL KINDS PEOPLE ENTER PLANT AND SECURITY THERE WOULD NOT BE GOOD.
- WHEN L-1 ASKED <sup>BY</sup> "STAY WITH" ARENAL HE SAID THAT ALTHOUGH HE "REVOLUTIONARY" HE NOT "COMMUNIST REVOLUTIONARY" AND COULD NOT "PLAY ALONG" WITH ARENAL FOR FEAR MEXI GOVERNMENT BECOME AWARE HIS ASSOCIATION. WHEN ASKED RE CUBAN EMBASSY AID ARENAL L-1 SAID ARENAL NOT CONNECTED CUBAN EMB. THIS NOT TRUE, OF COURSE, VIEW LITAIT-1 INFO REF B.
