1. (C) Inclosed are copies of two personal letters written by Raymond F. Friesecke to Lt Col John Connolly, Assistant Chief of Staff, G4, 2d Infantry Division, Fort Benning, Georgia. They are furnished for your information since their content indicates that Friesecke may be associating with militant, anti-Castro, Cuban elements in the United States and may have unauthorized access to classified US Government information.

2. (C) Records of the US Army Counterintelligence Records Facility, Fort Holabird, Maryland, contain the following information concerning subject: Friesecke was born on 12 March 1939 in Brooklyn, Massachusetts. He graduated in June 1959 with a BS degree from Boston College, Chestnut Hill, Massachusetts, and subsequently studied at the Massachusetts Institute of Technology. He entered the US Army on active duty on 22 July 1961 as a Second Lieutenant, serial number 0-5006664 and was assigned to Fort Benning, Georgia. Source of his commission was the ROTC Program. He was granted a SECRET clearance by the ACofS, G2, Fort Benning, on 20 October 1961 based on a favorable National Agency Check. A background investigation was initiated on 30 October 1962 to determine his suitability for access to TOP SECRET information. The investigation was discontinued as subject was discharged from the US Army on 20 January 1963. Records checks and eleven (11) interviews contained in incomplete investigation were non-derogatory.

3. (C) The source of the letters is Lt Col Connolly, who has voluntarily furnished them through channels to this office as a matter of possible interest. It is requested that his identity as the source be held in confidence and that this office be furnished prior notification if addressee should desire to interview him concerning the subject.
