STATIONERY USED FOR LETTER FROM HABANA APPEARS GENUINE. BOTH DOCUMENTS HAVE AUTHENTIC FLAVOR. ATTEMPTING OBTAIN BLANK VISA APPLICATION FOR COMPARISON.

2. LITAMIL-9 RECENTLY RECEIVED LETTER FROM MERCY MARTINEZ WHO ACTUALLY SIGNED LETTER FROM HABANA. WILL CHECK SIGNATURES WHEN L-9 LOCATES LETTER.
