- LITAMIL-9 HAS NOTHING ADDITIONAL TO OFFER BEYOND ACCOUNT OF MEXI 7115 EXCEPT THAT SILVIA SAID AT THAT TIME THAT SHE WAS PERFECTLY WILLING TRAVEL TO U.S. TO CONFRONT OSWALD IF NECESSARY. L-9 DID NOT TALK TO SILVIA ABOUT OSWALD VISIT, MERELY STOOD AROUND WITH OTHER STAFF MEMBERS WHILE SILVIA RECOUNTED ARREST, INTERROGATION, RELEASE. SILVIA DID NOT MENTION ANY DETAILS OF HER ENCOUNTER WITH OSWALD.
- L-9 REPORTED ON 27 DEC THAT SILVIA HAS NOT RETURNED TO WORK SINCE RELEASE FROM SECOND ARREST. HER HUSBAND WAS ANGRY OVER FOMIN ROA NOTE WHICH MADE CAUSE CELEBRE OF AFFAIR, TOLD PERUMEN EMBASSY OFFICIAL THAT ROA NOTE INACCURATE IN CLAIMING SILVIA MISTREATED BY MEXICAN POLICE.
