For information of Dallas and San Antonio, photograph of captioned subject was identified 12/9/63 by TP 139-PSI as GILBERTO LOPEZ, who was present at gathering of Fair Play for Cuba Committee, Tampa Bay Chapter (FPCC-TP) 11/k7/63 in private residence, Tampa, Fla. Informant described subject as white male, about 23, 5'7"; 125 lbs.; dark hair, parted on left side; light eyes; fair complexion; prominent nose, high bridge; very neat clothes and spoke very little English. Subject was expecting telephone call from Cuba that day, in order to get word on his departure for Cuba.

At regular meeting of the FPCC-TP on 12/8/63, attended by TP 139-PSI, two officers of group remarked that subject had made it to Cuba safely, according to telephone
