On December 27, 1963, PCI was contacted in an effort to locate a stripper known only as "YUM YUM". It should be noted that SA EDWARD P. GAZUR was trying to locate this stripper who reportedly had worked for JACK RUBY in Dallas.

PCI advised that "YUM YUM's" real name is STELLA KALIFA who is currently working as a stripper for JACK and AL WEINSTEIN at the Roxy Musical Bar at the corner of East 9th and Chester. PCI revealed that this individual resides at the Village Apartments about East 15th and Payne.

It should be noted that this information was extremely helpful in the expeditious location and interview of this girl.
