Re Newark airtel to Bureau, 5/3/64.

By letter dated 3/3/64, the Newark Division furnished information received from NK 1913-S that subject is scheduled to speak in Newark, New Jersey, on 8/23/64. This information was received by informant at SWP meeting held 7/19/64, at which MURRAY ZUCKOFF, SWP member, commented that LANE has real proof that LEE HARVEY OSWALD did not kill President JOHN F. KENNEDY and that he, LANE, had interviewed a female witness who saw OSWALD at that time of the assassination but who was never questioned by the FBI.

No further details re site or sponsor of LANE's speech in Newark known at this time.

Newark is requested to determine all details re scheduled LANE appearance and attempt to provide

RE: VIADUCT
ESPIONAGE - RUSSIA (S) (u)

Reference is made to Report Number 27 captioned
"Personalities in Radio Moscow Known to Viaduct." (S)

In this connection there is enclosed a photograph
of six individuals who were reportedly members of the North
American Section of Radio Moscow as of June, 1960. The date
of the enclosed photograph is unknown. (S) (u)

The individuals depicted in the enclosure, reading
from the viewer's left to right are reportedly identifiable
as follows: (1) Mikhail Sargayev; (2) Annette (Anita)
Setyeva, nee Zueff formerly known as Annette Goldsteina
(Goldstein) and Annette Rankina (Rankina); (3) Joseph
Adarov; (4) Annabelle Ducar; (5) Sergei Rudin; and (6) Lucy
Drovalina. (S) (u)

Joseph Adarov is believed identical to the person
of same name who is referred to in paragraph two of Report
Number 27 and Annabelle Ducar is believed identical to the
person referred to in paragraph six of the report. Sergei
Rudin is likely identical with the Rudina referred to in
paragraphs 11 and 17 of the report. (S)

Annette Setyeva is believed to be identical with
the Annette Goldstein (Rankina) referred to in paragraph 14
of the report. (S) This person was born October 18, 1919, at
Lake Stevens, Washington, to William H. Zueff, a Russian
national, and Billie Kay Edwards who was born at Northland,
Michigan, in 1902. Setyeva's mother is presently known as
Billie Kay Rank and resides at Kotzebue, Alaska. (S) (u)
