On 12/4/63, DL-6-S, in person, furnished typewritten report to SA W. HARLAN BROWN, which report was dated 11/25/63, and has been serialized as 134-1A-800A.

That report revealed that JOE LANDIN visited AUGUSTIN ESTRADA at his home on Monday night. He wanted to know if AUGUSTIN had heard from JOHN STANFORD. ESTRADA said he had not and he had been, for a time, concerned about his welfare since the assassination of the President. AUGUSTIN said he was quite sure that he would hear from STANFORD the following week. If he did he would contact JOE. LANDIN questioned him about OSWALD, was he, he asked, Party people? ESTRADA said he was quite sure he was not; he had never heard of him. He believed the Right-wing extremists had hired the "Syndicate" to murder the President and added that some of the local police may be in on it. Why, he pointed out, did they want to close the case so soon? The FBI was right, he added, to continue the investigation. JOE asked him if he should get rid of the Marxist literature. ESTRADA advised him to save it if it could be done safely, if not he should get rid of it.

JOE asked him what he meant by the "Syndicate". By the "Syndicate" he explained, he meant gangsters. RUBY, he pointed out, had many connections. Besides OSWALD's case was too simple, too easy. He had defected to Russia, married a Russian girl, was supposed to be active on a pro-Cuba organization and had a picture taken with a gun and a rifle with telescopic lens and a copy of The Worker.
