Information from the Chesapeake and Potomac Telephone Company of Maryland, Baltimore, Maryland, reflecting no record of Baltimore Publications, Inc, Angola Building, or phone TL 6-2770, was furnished on December 13, 1963, by BA CS #2 to Special Agent J. STANLEY ROTZ.

On December 17, 1963, Postal Inspector H. A. WESCOTT, Baltimore, Maryland, advised Special Agent ROTZ he had checked appropriate files and individuals in the Baltimore, Maryland Post Office, but could find no record or recollection of an Angola Building in the area.
