Informant advised that on November 21, 1963, he and JIM WALCROFT, a white male, who is a real estate broker, maintaining offices on Annapolis Road near the Robert Hall Clothing Store, had gone to Annapolis, Maryland, where they had contacted a Mr. and Mrs. NOEL R. WHITE, both of whom are members of the Caucasian race, and who reside at 2272 Southaven Road, Annapolis, Maryland.

The WHITES own a considerable amount of land around the Lanham - Vista area in Prince Georges County and informant and WALCROFT were attempting to obtain permission to sell some of this land to Negroes for Negro housing.

Informant certified that he has furnished all information obtained by him since last contact.

C. suburban area ensued and Mrs. WHITE made the statement that President KENNEDY was responsible for stirring up the Negroes and integration and further made the statement, "Somebody ought to kill him."
