> URGENT HAVE SEEN RCMP IN VANCOUVER BC. HAVE VERY IMPORTANT INFORMATION VITAL TO USA GOVERNMENT. I WOULD TRAVEL TO BELLINGHAM TO SEE YOU IF YOU SAY TO COME IMMEDIATELY I CANNOT SAY TOO MUCH AS TO SUCH PROOF I HAVE TO GIVE YOU. I CAN IDENTIFY SUCH PHOTO ON TV TODAY BUS LEAVES VANCOUVER AT 1245PM I HAVE FUNDS TO STAY FOR A DAY OR SO URGENT REPLY CARE OF CNT VANCOUVER

At 12:15 AM 23 November 63 to the C.N.R. Telegrams  $\bigvee$  where we saw the a/m Compl. who had sent a wire to AL GUNN, F.B.I. Bellingham, and had called to see if there was an answer.

GOURLEY stated that about three weeks ago he and two friends were in the Hilden Hotel drinking in the men's side and he, GOURLEY, overheard three men talking about KENNEDY and if he ever went to Dallas, Texas, he would never leave there alive. The

men were going to ge to Cuba afterwards. One of them said that his uncle had a foreign rifle. GOURLEY states that he was the man in the picture shown on T.V. that was talking about the rifle. His name was LEE, and he was wearing a grey suit and a brown shirt.

COURLEY gave the names of his friends that could confirm this. A JOHN LANG, 1116 Bute Street, MU 3 2892, and an old man named PERCY WHITTIKER, #9, the Dominion Hotel.

JOHN LANG was interviewed by the u/s and the had no knowledge of this incident. He states that GOURLEY's imagination runs away with him at times. The two men were brought tegether and they discussed the incident, but LANG did not remember it

GOURLEY was taken home to the a/m address. He stated that he was willing to go to the Statesto find the other two men that had been LEE, as he was the only one that had seen him, he was also willing to go to Guba. He said that he would like to get a job in the States as he is out of work at present.

When first spoken to GOURLEY had a cab and intended going to the Bus Depot to get a bus for Bellingham to see the F.B.I. He had a passport with him. He was advised that AL GUNN may contact him. GOURLEY had been drinking during the evening and had the paper covering the shooting of the President. The u/s are of the opinion that he has imagined a connection with it.
